**PARKING AT THE SCHOOL OR THE OFF CAMPUS PARKING LOT IS A PRIVILEGE. DRIVERS MUST FOLLOW THE FOLLOWING PARKING RULES:**

1. PARKING PERMIT MUST BE PLACED ON REARVIEW MIRROR OR DASHBOARD AND THE PERMIT # MUST BE VISIBLE.
2. BUCKLE UP
3. DRIVE SLOWLY (10 MPH) ON CAMPUS, SAFETY FIRST, SAFETY ALWAYS  
(NO PERSONS ON TOP OF VEHICLE OR IN BED OF TRUCK)
4. DO NOT DRIVE ON THE FORMATION AREA (THE RED BRICKS WILL BREAK)
5. DO NOT PARK IN STAFF, VISITOR, OR HANDICAP PARKING AREA
6. PARK ONLY IN DESIGNATED STUDENT PARKING AREAS
7. DO NOT SHARE PERMITS WITH OTHER CADETS
8. GET HERE ON TIME, DO NOT BE LATE TO FORMATION, NOT BEING ABLE TO FIND A SPOT TO PARK IS NOT AN EXCUSE
9. DO NOT GO TO YOUR CAR DURING SCHOOL HOURS (7:15AM -1:40PM) NO EXCUSES, TAKE EVERYTHING WITH YOU
10. DO NOT LOITER IN OR AROUND CARS
11. SMA IS NOT RESPONSIBLE FOR ANY DAMAGE THAT MAY HAVE BEEN CAUSED TO YOUR VEHICLE
12. SMA IS NOT RESPONSIBLE FOR ANY LOST, STOLEN, OR DAMAGED ITEMS INSIDE YOUR VEHICLE
13. SMA RESERVES THE RIGHT TO SEARCH YOUR VEHICLE IF THERE IS REASONABLE SUSPICION
